THE FOLLOWING RULES WILL BE ENFORCED:

- 1. ABSOLUTELY NO EARLY BREAK DOWNS! Break down at 9:00p**
2. Vendors agree to be ready for booth inspection no later than one (1) hour prior to the start of event operating hours.
3. Vehicles are strictly prohibited through the pedestrian zones of an event during the hours of the event.
4. Each vendor is responsible for ensuring the cleanliness of his or her area, especially at the conclusion of each event day. Event staff provides lined trash cans throughout the event for the general public. Vendors are expected to pack out heavy product, packing materials or mass amounts of product. Failure to leave the venue in a clean and orderly fashion will result in the review of a vendor's ability to participate in future events.
5. No vendor shall harass or disturb any other vendor in the event area. Vendors should remain in their respective areas. Harassment will not be tolerated at event and could result in being banned from all future events.
6. Any vendor who does not comply with all of the rules listed will be asked to leave immediately and will forfeit their pad fee, as well as any opportunity to participate in future events.

VENDORS AGREE TO HOLD HARMLESS FMVSA, PETE'S WAY STAFF, ALL SOULS FEST STAFF AND ALL ASSOCIATED VENUES AND VENDORS OR ANY AGENT, EMPLOYEE, OR REPRESENTATIVE AFFILIATED WITH FMVSA, ALL SOULS FEST FREE FROM ANY AND ALL TYPES OF LIABILITY, ACCIDENTS, FIRE, THEFT, NATURAL DISASTER, OR ANY LOSS OF ANY KIND.
